Important Information

Official language

South Africa has 11 official languages but at the Congress only ENGLISH will be spoken. No simultaneous translation will be provided.

Climate

At the Sun City Resort: Day temperatures in September are mild: 20-30°C during the day and 10-15°C at night. Midwinter occurs in June and July and Midsummer in December and January.

In South Africa: The climate ranges from Mediterranean in the Cape Peninsula to subtropical on the KwaZulu-Natal coast and in the North Eastern regions, while temperate conditions prevail inland: High 28°C and Low 12°C.

Medical service

South Africa does not have a national health scheme. The patient is individually responsible for settling all accounts. Travel insurance covering accidents, illness or hospitalization during your stay is strongly recommended. The Sun City Resort where the congress is being held has 24 hour medical and emergency services. The Resort as well as the adjacent Pilanesberg National Park is a **MALARIA FREE** area.

Malaria

Malaria is found only in the Lowveld of Mpumalanga and Limpopo and on the Maputaland coast of KwaZulu-Natal. Although the incidence of malaria is rare, it would be best to take adequate precautions if you choose to visit these areas.

The cheapest, safest and most effective measures against malaria are physical barriers such as a mosquito net, and the use of a good insect repellent. If you decide to take malaria prophylaxis, it is essential that the drugs are taken according to the directions on the package insert. You will need to start a week or two before entering a malaria-endemic area and should continue taking the drugs for four weeks after leaving the malaria risk area. It is advisable to consult a medical professional before embarking on a course of malaria prophylaxis.

Vaccinations

Visitors entering South Africa from a yellow fever zone must have a valid international yellow fever inoculation certificate. Immunization against cholera and small pox are not required, nor are other vaccinations required when visiting South Africa.

Certificate of attendance

Certificates will be available ON REQUEST ONLY at the end of the Congress at the Registration Desk. CPD points will be allocated to delegates attending CECs. Certificates of attendance for the CEC (Continuing Education Courses) will also be available ON REQUEST ONLY at the end of courses at the Registration desk.

Liability and insurance

Registration for the Congress implies that delegates agree that neither the Local Organizing Committee nor the Professional Congress Organizer assume any liability or responsibility for any losses, accidents or damage to a person's private property. Delegates are requested to make their own arrangements for medical, travel and personal insurance.

Currency and exchange

The South African Rand is the local currency (R1 = 100 cents). Foreign exchange can be done at banks or foreign exchange centres at the airport on arrival, or in any of the casinos in the resort from 08:00 until the casino closes every day. A passport will be required for ALL transactions.

Credit cards, shopping

Foreigners can claim sales tax refunds and should ask salesmen to fill out a tax refund form when purchasing any goods. All major credit cards are accepted throughout South Africa, as well as Traveler's cheques. Various automatic teller machines are also available on the resort.
